RESOLUTION TO CLOSE THE MUNICIPALITY'S BRIA FARMERS SPECIAL ACCOUNT NO. 3292-1045-95 AND THE MUNICIPALITY'S KALAHI CIDSS-NCDDP TRUST ACCOUNT NO. 3292-1045-10 WITH THE LAND BANK OF THE PHILIPPINES (LBP) JARO BRANCH, JARO, ILOILO CITY

WHEREAS, the Municipality's BRIA-FARMERS Special Account No. 3292-1045-95 will no longer be active in as far as banking transaction is concern because the programs and projects of the BRIA-FARMERS with this municipality has long been completed and terminated, thus no more transaction relative to the same shall be made;

WHEREAS, in same manner that the municipality's KALAHI CIDSS- NCDDP Trust Account No. 3292-1045-10 will likewise be no longer active in so far as banking transactions is concerned as KALAHI CIDSS-NCDDP Projects implementation has long been terminated, thus no transactions relative to this matter shall be made;

WHEREAS, in view of the above, the Sangguniang Bayan of Mina deemed it necessary to close the above-stated accounts with the LBP- Jaro Branch to avoid incurrence of additional penalty therefrom. Proceeds of the above-mentioned closed account shall be credited to: Account Name-Municipality of Mina; Account No. 3292-1043-31.
