**WHEREAS**, presented for consideration is the letter received from the Office of the Mayor requesting authority to sign in the Memorandum of Agreement for work immersion partnership with the Western Institute of Technology (WIT) pursuant to Section 444 (b) (1) (vi) of RA 7160;

**WHEREAS**, the Department of Education of the Philippines is the primary government instrumentality mandated to formulate, implement and coordinate policies, plans, programs and projects in the areas of formal and non-formal basic education, supervise all elementary and secondary education institutions, including alternative learning systems, both public and private; and provide for the establishment and maintenance of a complete, adequate, and integrated system of basic education relevant to the goals of national government;

**WHEREAS**, the DepEd has introduce the K to 12 basic education reform program that includes Senior High School (SHS) with the major objective at ensuring that graduates of basic education are ready for employment, entrepreneurship and higher learning;

**WHEREAS**, the SHS can be customized at the local levels to take into consideration the needs of local industries and the labor market;

**WHEREAS**, the DepEd believes that for effective delivery of shs instruction there is a need for school industry partnerships that will provide the school the necessary expertise and venue for practical, on-the-job, enterprise-based training for SHS learners;

**WHEREAS**, WIT is among those that will offer SGS to students in the community to carry-out DepEds objectives for SHS as above-stated;

**WHEREAS**, to achieve this objective, the WIT needs to enter into a work immersion partnership with this LGU;

**WHEREAS**, the WIT and the LGU-Mina undertake to collaborate for the successful implementation of the SHS cognizant of the need for special protection of the child with the best interest of SHS learner pursuant to R.A. 10533 otherwise known as the enhance Basic Education Act of 2013.
