**RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR, HON REY P. GRABATO, TO ENTER AND SIGN INTO A MEMORANDUM OF AGREEMENT (MOA) WITH PROVINCIAL GOVERNMENT OF ILOILO REPRESENTED BY GOVERNOR ARTHUR D. DEFENSOR, SR., FOR THE IMPLEMENTATION OF ZERO OPEN DEFECATION MOVEMENT**

**WHEREAS**, open defecation is the practice of defecating outside and not into a designated toilet. It is usually happened in fields, rivers, and open trenches which may cause water-food borne diseases;

**WHEREAS**, zero defecation movement is established to provide, toilet facilities to households in the municipalities thereby elementary open defecation among the populace;

**WHEREAS**, to ensure successful implementation of the program, both the Municipality and the Province agreed to execute a Memorandum of Agreement (MOA) stipulating therein specific obligations and responsibilities of each party;

**WHEREAS**, an authority to sign in the MOA by the Municipal Mayor from this Sanggunian is required pursuant to Section 444 (b) (1) (vi) of RA 7160, thus this Resolution.
