**RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR, HON. REY P. GRABATO, TO ENTER AND SIGN INTO A CONTRACT OF WORK WITH NOE'S BUILDERS REPRESENTED BY NOEMI GEVERO, PROPRIETOR FOR: 1.) REPAIR/IMPROVEMENT OF MPP BUILDING/EMBANKMENT AND CONSTRUCTION OF PARKING AREA FENCING AND RAMPS (COMELEC RIGHT SIDE), AND 2.) CONSTRUCTION OF MPP BUILDING/EMBANKMENT AND CONSTRUCTION OF PARKING AREA AND FENCING (BSPO LEFT SIDE), MINA EAST, MINA, ILOILO**

WHEREAS, presented for consideration is the letter received from the Office of the Mayor requesting authority from this Sanggunian to sign in the Contract of Work for the – projects above-stated pursuant to Section 444 (b) (1) (vi) of RA 7160;

WHEREAS, the LGU of Mina has appropriated the total amount of Two Million pesos (P2,000,000.00) for the improvement of Multipurpose Building, re: 1.) Embankment and Construction of Parking Area Fencing and Ramps for COMELEC at the right side – P1,000,000.00; and 2.) Embankment and Construction of Parking Area and Fencing for BSPO at left side-P 1,000,000.00;

WHEREAS, the said projects were submitted to a public bidding through One (1) Job Contracts-furnishing of labor and materials, and Noe's Builders got the lowest responsive calculated bids for both projects (1 &2) in the amount of P 998,640.00 and P 998,856.20 respectively, to whom the contracts were awarded to;

WHEREAS, an authority to sign in the contract by the Mayor from this Sanggunian is required, hence this resolution.
