**RESOLUTION NO.2016 – 001**

**RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR HON. REY P. GRABATO, TO ENTER INTO AND SIGN IN THE MEMORANDUM OF AGREEMENT (MOA) BETWEEN THE ILOILO PROVINCIAL GOVERNMENT REPRESENTED BY HON. ARTHUR D. DEFENSOR, SR., GOVERNOR, PROVINCE OF ILOILO AND THE LOCAL GOVERNMENT UNIT OF MINA**

**WHEREAS**, protecting the children and ensuring promotion and fulfillment of the Child's right is one of the primary concerns of the Iloilo Provincial Government (IPG);

**WHEREAS**, one of the categories of the child's rights that need to be addressed by the IPG is their protection rights;

**WHEREAS**, one of these protection rights is the provision of access to facilities for Children In Conflict with the Law (CICL) as stipulated in various national and local laws such as Republic Act No. 9344 (Juvenile Justice and Welfare Act of 2006), Republic Act No. 10630 (An Act Establishing a Comprehensive Juvenile Justice and Welfare Council Under the Department of Social Welfare and Development, Appropriating funds therefore; and for other purposes), and the Iloilo Province Local Code for children;

**WHEREAS**, the absence of a center for CICL that is owned and managed by the IPG has a direct impact on the implementation of laws related to protection of child's rights and to address this gap, CICLs are referred to BALAY PAGLAUM, owned and operated by the Municipality of Mina which serves as temporary shelter and provider of restorative service;

**WHEREAS**, BALAY PAGLAUM was established to resolve cases on CICL and other behavioral patterns or problems in ways that strengthen their coping capacity and encourage personal responsibility, to protect them from further exposure to calamities, exploitation, abuse, neglect, displacement and substance abuse, and to enable them to restore their normal functioning towards family and community re-integration;

**WHEREAS**, the same is hereby operational and ready to accept clients coming from other municipalities within the Province as "catchment" or temporary shelter for not more than three (3) weeks as specified in the Municipal Ordinance No. 2012-212;

**WHEREAS**, in line thereto, the IPG needs to execute a Memorandum of Agreement (MOA) with the second party for the transfer of funds amounting to ONE HUNDRED THOUSAND PESOS (P100,000.00) to ensure delivery of quality and continuous services to the referred CICLs.

**NOW, THEREFORE:**

**BE IT RESOLVED** by the Sangguniang Bayan of Mina, Province of Iloilo to pass a RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR HON. REY P. GRABATO, TO ENTER INTO AND SIGN IN THE MEMORANDUM OF AGREEMENT (MOA) BETWEEN THE ILOILO PROVINCIAL GOVERNMENT REPRESENTED BY HON. ARTHUR D. DEFENSOR, SR., GOVERNOR, PROVINCE OF ILOILO AND THE LOCAL GOVERNMENT UNIT OF MINA.
