WHEREAS, the Mina Laboratory and medical clinic is now operating under the Municipality of Mina the management and control of the Office headed by the Municipal Health Officer, Dr. Jeanette A. Sobrevega;

WHEREAS, Pototan Medilab, Inc., managed by May Flor G. Andora, with Office address at Rumbang, Pototan, Iloilo is duly recognized clinical laboratory of the Department of Health authorized to perform specimen laboratory examination;

WHEREAS, Pototan Medilab, Inc., is at all times available and ready to accept specimens sent to them by the Municipality of Mina for laboratory examinations in case the same is not available in the former's laboratory in accordance with the policies, procedures and guidelines governing SENT-OUT HUMAN SPECIMEN of the Department of Health;

WHEREAS, the MOA between the LGU and the Pototan Medilab, Inc. is about to expire, which needs to be renewed, hence this authority.
